- A. Jeff called meeting to order at 7:05
- B. Quorum met (min 50% of executive)
- C. Shaina approved the agenda with move of new business to first discussion item.

- E. Reports of the Executive Directors
  - a. President
    - i. two current discipline reports currently being investigated with discipline committee (U13C / U13B)
    - ii. one current maltreatment allegation currently being investigated with Hockey Alberta
    - iii. Plavoffs
      - 1. U13 / U15 Playoffs start Feb 17
      - 2. 3-U13, 3-U15, 2-U18 RMAA teams in playoffs. Series are to be finished in the weekend they start (unless no time restraints). If ice is too challenging to get, total goal format may be used to declare a winner.
      - 3. U13-Tier 1 League Champion must be declared by Mar 12. U13 Blue gets venue for round robin, provincials will be March 23-26 in Calgary.
      - 4. U13-Tier 4 League Champion must be declared by Mar 12. U13 Tier 4 White gets venue or round robin followed by green, yellow, red, blue and possible wild card. May start playing games in advance for the final rounds as teams become available. Winners will playoff in a series over two weekends and play in final for a tier 4 banner March 10-12.
      - 5. U13- Tier 5- no timeline pressures needed.
      - 6. U15- Tier 5 Blue gets venue for round robin, followed by green and red.
      - 7. U15 Tier 2 winners will play for tier 2 championship banner and provincial berth on Mar 10-12. U15- Tier 2 blue get venue for round robin followed by green and red. Winner plays at provincials in Lacombe Mar 23-26.
      - 8. U15 Tier 3 tight timelines. All teams can play off for opportunity to play in the tier 3 final, for provincial berth. All teams losing a playoff series would play out in the consolation side playoff. The winner of tier 3 "C" champion banner will play for a chance in the final with the winners from tier 3 red, orange, white. CAHL tier 3 winner will be playing at provincials in Tofield Mar 23-16.

- 9. U15- Tier 4 winners of tier 4 red and blue will playoff one weekend series and play in the final for a tier 4 banner Mar 10-12. U15 Tier 4 Blue gets venue. Winner and runner up will play in Plamondon at the Provincials Mar 23-26.
- 10. U18 Tier 1 The four original tier 1 teams will be separated and will have their own red and blue playoff, who will then play for a tier 1 banner. U18- tier 1 blue gets venue. CAHL runner up will also go to provincials in Strathmore Mar 30-Apr
- 11. U18- Tier 3 winner will be playing at provincials in Provost Mar 30-Apr 2.
